



REQUEST FOR ISLAMIC (SWAP-FREE) TRADING ACCOUNT

ISLAMIC (SWAP-FREE) TRADING ACCOUNT USE AGREEMENT

Introduction

This Islamic (Swap-Free) Trading Account Use Agreement («Agreement») is a supplement to the Terms & Conditions of Business and governs the terms of Islamic (Swap-Free) Trading Accounts with Profit Planet. For the purpose of this Agreement, unless the context otherwise requires, the terms used herein shall have the meanings assigned to them in the 'Definitions' section of the Terms & Conditions of Business.

Acceptance and Submission

By completing and/or submitting to Profit Planet the Islamic trading account request email and/or documentation/forms posted on the Company's Online Trading Facility ("Request for Islamic (Swap-Free) Trading Account"), clicking the appropriate space, "Open an Islamic Account," "I Accept" button, or similar buttons or links as designated by the Company, the Client indicates approval and acceptance of this Agreement. The successful submission of a request to convert the Client's trading account(s) into Islamic (Swap-Free) account(s) ("Request") is required.

Eligibility and Conditions

Islamic (Swap-Free) trading accounts are available exclusively to Clients who cannot use 'swaps' due to their religious beliefs. In all cases where a Request for an Islamic (Swap-Free) trading account is submitted, Profit Planet reserves the right to require justification and/or proof of the necessity for such conversion. The Company retains the sole discretion to refuse any Request, for any reason, without the obligation to provide an explanation or justification. Clients may submit a Request for an Islamic (Swap-Free) trading account at any time; however, all other real trading accounts of the Client will automatically convert into Swap-Free trading accounts without further notice upon submission. Profit Planet will evaluate the Request and inform the Client by email whether the Request is accepted or not. The terms herein will take effect as of the date when the Company sends the confirmation email approving the Client's Request.

Usage Restrictions

Clients are prohibited from using Swap-Free trading accounts to profit from 'Swaps' and cannot request payment for any 'Swap' amounts lost due to the conversion of their real trading account(s) into Swap-Free account(s) for the period before the conversion. Profit Planet reserves the right to revoke the Swap-Free status of any real trading account at any time, at its sole discretion, without the need to provide an explanation or

justification.

Abuse, Fraud, and Account Closure

If Profit Planet detects any form of abuse, fraud, manipulation, 'interest'/'cash-back arbitrage,' or other deceitful or fraudulent activity related to any Swap-Free account of a Client, the Company reserves the right, at any time, to:

- (i) Revoke the Swap-Free status from any or all real trading accounts of the Client converted to Swap-Free accounts with immediate effect.
- (ii) Correct and recover any un-accrued Swaps and related un-accrued interest expenses or costs associated with the Client's Swap-Free trading accounts during the period of conversion.
- (iii) Close all trading accounts of the Client with the Company, nullify all trades conducted in such accounts, and cancel any profits or losses incurred.

Language and Discrepancies

If this Agreement is translated into a language other than English, the English version shall prevail in the event of any inconsistency or conflict.
